
Marking and grading: GCSE, AS and A level

VTQs follow the same or a similar approach, with grading tailored appropriately to the qualification.

Schools and colleges will receive results the day before results day

JCQ will publish the results (across England, Wales and NI) on behalf of the exam boards


On results days Ofqual will be publishing:

- Infographics GQ and VTQ to highlight key figures/trends
- Interactive analytics will be refreshed, including region and centre type breakdowns
- Press release

Equalities analysis will be published in the autumn

Reviews of marking and moderation, and appeals (GCSEs, AS and A levels)

- A school or college can, on behalf of a student:
- Request access to marked scripts
- Request a review of marking or moderation if it feels there has been an error
- Request priority review of marking university/HE/FE place
- Appeal if it feels an error remains after the review
- Ask Ofqual's EPRS to undertake a final review



For VTQs: Awarding organisations have their own processes for reviews of marking, moderation and appeals.

VTQ Information Hub

 Contains key dates and deadlines for qualifications that are taken alongside or instead of GCSEs and A levels.

 Check Awarding Organisations' websites to check when assessments are taking place to plan for any disruption to teaching time.

 The VTQ Information Hub is planned to go live in November for the 2025/26 academic year.

- The National Cyber Security Centre (NCSC) provides <u>resources to help schools improve their</u> <u>cyber security</u>
- JCQ has published guidance on cyber security in schools and colleges



Long-term resilience arrangements

Ofqual <u>Guidance on collecting</u>
<u>evidence of student performance to</u>
<u>ensure resilience in the qualifications</u>
<u>system</u>

Gather evidence that aligns with normal arrangements

Awarding organisations provide guidance for specific VTQs

Long term arrangements

Sufficiently robust contingency measures should be in place in case the exams officer is absent.
